#### ENTRIES CLOSE - April 9th, 2025 at 12:00 pm CST

- Entries received after closing cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows.
- Entries can be made by mail to the Event Secretary on an official AKC entry form.
- Entries are accepted in order of time stamp or post mark.
- Overnight or certified mail must be sent "No Signature Required".
- No entries will be accepted by phone, fax, or hand delivery.
- A \$25 collection fee will be added to the amount of each returned check.
- Illegible entries will not be processed and will be returned to the exhibitor.
- Returned checks or unpaid entries do not constitute a valid entry.
- No entries may be withdrawn with a refund after closing day/time except as allowed by regulations.
- Juniors must provide AKC junior number to be eligible for class discount.
- Junior is defined as someone who is less than 18 years of age on the first day of the event.
- Junior must handle dog to be eligible for junior discounted entry fee.
- An entry is defined as a single run by a single dog in a single class.
- Inquiries may be directed to the Event Secretary.

#### **ENTRY**

Fee - \$25 advanced entry / \$30 day of event entry \*

Junior Fee - \$15 advanced entry / \$20 day of event entry\*

\* Entry fee includes \$3.50 per run AKC recording fee

Day of Test Entries - at Event Secretary's table until 1 pm, checks payable to MCKC

Limits - 150 per test

Method - first received

Fun Runs - \$5 per run, offered throughout day as time permits

#### **TRIAL**

**Hours** - 8:30 am with last dog on the line at 4:00 pm Friday & Saturday and 3:00 pm Sunday \*

\* Members of the event committee may run 1/2 hour prior to published start time

Schedule - test 1 & test 2 to run concurrently each day

Course - fenced, flat, dirt horse track with a minimum 50 yard run-out

Inspection - mandatory before every run for fitness, lameness, and "in-season" females

System - battery-powered continuous loop with electronic timing system

Lure - plastic bag



#### **DOGS ELIGIBLE TO ENTER**

Dogs who are twelve (12) months of age or older and registered with AKC, recorded with Foundation Stock Service (FSS) program, registered with a foreign or domestic registry whose pedigrees are acceptable for AKC registration, granted a Purebred Alternative Listing (PAL) number, registered AKC Limited, or enrolled in AKC Canine Partners program are eligible to enter.

Dogs that are physically challenged due to loss of limb are eligible to enter and should be given the same consideration by the inspection committee as four-legged dogs. For safety purposes, any dog requiring an assistance apparatus, such as a wheeled cart, will not be allowed to participate.

A dog that exhibits a state of well-being at the time of inspection, shows no signs of physical discomfort, and in the opinion of the inspection committee appears to physically have the potential to safely complete the course, is to be considered fit to participate.

Bitches that are in season are not allowed to participate.

#### **REFUNDS & CANCELLATIONS**

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee. Entries withdrawn for any reason are not eligible for a refund, except bitch in season or dogs determined to be lame or unfit to participate by the Inspection Committee at the time of roll call, by the owner/agent at the time of roll call, or upon previous notification by the owner/agent. A full refund will be issued for these exceptions.

Cancellation of entries must be in writing and received prior to the stated close of entries. A full refund will be issued.

#### **ABOUT FAST CAT**

Fast CAT is a timed straight race of 100 yards where the dog chases a lure. Dogs run individually earning points based on their handicapped speed. The handicap system is based on the height of the dog at its withers. There are no placements and titles are earned by accumulating points.

BCAT - 150 points, DCAT - 500 points, FCAT - 1000 points, FCAT# - every 500 points

Handicap - 18" or greater = 1.0, 12" up to 18" = 1.5, 12" or less = 2.0

Points = MPH(204.545/time)x handicap

#### SITE INFORMATION

Battery-powered, continuous loop equipment will be used with lures consisting of white plastic bags. The length of run-out will be a minimum of 50 yards and up to 60 yards. The test surface is a flat, grass field with a parameter fence. The test track will be fenced with temporary fencing. An electronic system will be used with manual timing as a back-up.

Only participants who are running their dog are allowed on the track. Shoes are required on event grounds. Children must be supervised by an adult at all times. Violators will be asked to leave and entries will not be refunded.

#### TIPS FOR HANDLERS

It is strongly recommended that prior to running your dog that you have a good "recall" as the dogs will be running off leash.

Handlers should wear comfortable shoes with good traction and should be physically able to hold and release their dog(s) as well as catch them.

Dogs are brought to the start line on leash and are released upon the verbal signal, "Tally Ho!", from the Hunt Master. Dogs may be released by hand, folded leash, or using a traditional lure coursing slip lead.

Dogs may run with or without a collar. **Unacceptable collars are slip collar, prong collar, or electronic collar.** Tags hanging from collar should be removed or secured. Clips or rubber bands may be used to hold back dog's hair.

The catcher is expected to promptly secure the dog in the catch area and leave the field with the dog on leash.

Coursing is a physically demanding sport and, for the safety of your dog, your dog should be in good fitness and soundness. If you are unsure, consult your veterinarian.

Handlers are advised to warm-up and cool-down their dog(s) by walking them for 10 minutes before/after their run.

Bring your own shade and water.

#### ALL DOGS RUN AT OWNER'S SOLE RISK



Any exhibitor or spectator whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. The Mid-Continent Kennel Club of Tulsa and its officers, representatives, volunteers, the Trial Chairperson/Secretary, Trial Committee, and Trial site assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assumes no responsibility for injury to children. The Mid-Continent Kennel Club of Tulsa reserves the right to decline entries for cause and may remove any dog on account of aggression. A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this trial.
